



**Non-Resident Tuition Waiver Form for Veterans and Dependents**

Florida Gulf Coast University shall waive the out-of-state tuition/fees for veteran and dependent students in accordance with Florida Senate Bill 7028 (Educational Opportunities for Veterans), who meet the following conditions (please see checklist below):

**Veterans, Reservists, FL Guard**

- DD-214 showing Honorable Discharge
- Proof of Residency within the state of Florida in the form of one of the following:
  - Florida driver’s license or State ID Card
  - Florida vehicle registration
  - Florida voter’s registration
  - Proof of homestead exemption in Florida
  - Proof of permanent employment in Florida (Letter on company letterhead stating that the claimant will be employed at least 20 hours per week)
  - A declaration of domicile in Florida
  - Proof of water, electric, or natural gas bill
  - Proof of a lease agreement

**Dependents (must be eligible, utilizing VA Education Benefits and need to be physically residing in FL)**

- Certificate of Eligibility
- Proof of Residency within the state of Florida in the form of one of the following:
  - Florida driver’s license or State ID Card
  - Florida vehicle registration
  - Florida voter’s registration
  - Proof of homestead exemption in Florida
  - Proof of permanent employment in Florida (Letter on company letterhead stating that the claimant will be employed at least 20 hours per week)
  - A declaration of domicile in Florida
  - Proof of water, electric, or natural gas bill
  - Proof of a lease agreement

To receive this waiver, complete the Student section below to include appropriate documentation attached and return to the Office of the Registrar. The Registrar’s Office will verify the information and forward to the Cashier’s Office for processing.

**A new waiver application is required annually.** Students are requested to seek in-state residency for tuition purposes by the end of their second term at Florida Gulf Coast University.
